#### SECTION II - PROJECT DESCRIPTION

### Please describe the purpose and intent of the grant.

EnrichLA is offering our Garden Ranger Program at the Academic Leadership Center at Miguel Contreras School . The Garden Ranger Program offers weekly, interdisciplinary garden-based lessons. These lessons correspond to the California Common Core standards and provide participants with hands-on opportunities to learn about nutrition, science, and environmental stewardship. By years end, hundreds of students at Academic Leadership Center at Miguel Contreras School will have engaged in the Garden Ranger Program. Our goal is to reach all students within the school. Generally, each school contributes around \$5,175 for the Garden Ranger Program. The full cost of the Garden Ranger Program is \$6,900 per year, including all overhead. We understand that \$6,900 is a large cost for many schools, though we also believe that once a school offers our program, it should never be taken away due to lack of funding. EnrichLA has received various public, private, and foundation grants, as well corporate sponsorships and anonymous donations. These funds go into the EnrichLA General Fund and supplement what the schools cannot pay. We are asking for \$1500 from the Neighborhood Council to offset the amount that EnrichLA contributes to support the non-personnel related expenses within the Garden Ranger Program. Though the program will not be canceled without the NC support, this NPG will allow EnrichLA to redirect outside funds that would've gone to support the Garden Ranger Programs, to be saved for program/ site developments and (inevitable) emergency garden repairs. (\$5175 from the school + \$1500 from NC + \$225 from EnrichLA General Funds = \$6900)

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

The Garden Ranger Program offered by EnrichLA positively impacts hundreds of people in the community served by this Neighborhood Council. Additionally, these gardens provide the surrounding community with access to open, green space. Community members—youths and adults alike—are routinely invited to participate in garden events. These garden events or garden workdays provide community members with a fun, active, fulfilling day spent enriching their own neighborhood. Garden workdays also offer the opportunity for neighbors to take home a bag of locally grown produce! While 68% of students in all of Los Angeles County are socioeconomically disadvantaged/ eligible for free or reduced fee lunches, on average, 85.9% of the students attending schools with EnrichLA's garden Ranger Programs are socioeconomically disadvantaged (figures from the 2016-2017 School Accountability Report Card). According to the CDC, 1 in 3 people will develop diabetes in their lifetime; whereas persons identifying as Latino or Black are 50% more likely to be diagnosed with diabetes than those white. With this program, our Garden Rangers plant seedlings with students and provide regular maintenance to the garden. Once these fresh fruits and vegetables are ready to be harvested, students prepare healthy snacks in their outdoor kitchen. Throughout this process, students are learning about science, life-cycles, composting, the importance of recycling, and are developing a hands-on relationship to the source of their food alongside classroom curriculum. We believe that all children, regardless of race or economic status, deserve to have access to green, outdoor spaces and healthy, natural foods.

## Westlake North Neighborhood Council

We are requesting funds to support the Garden Ranger Program at the Academic Leadership Center at Miguel Contreras School, which has a population of 472 students. This year ACL has semester rotations with four classes of 30-35 students in each class. Both semesters will have a full class of special needs students. We anticipate the program will serve at least 240 students, which is about half of the entire high school population.

We have provided a breakdown of our entire program costs as well as our budgeted materials costs for the 2017-2018 school year. Each Garden Ranger submits an invoice each month including all material costs that are used specifically for the educational program. This allows us to track exactly how much the educational program at one schools costs and varies from our other programs. In the past two years, the materials purchased by Garden Rangers has consistently averaged to be \$500 for the year. These costs include anything that Garden Rangers choose to use for their lessons and can include any teaching materials (poster boards, markers, notebooks, science equipment), cooking/snack materials (utensils cooking/prep materials, supplemental cooking ingredients), as well as any games or specific educational materials not supplied by EnrichLA.

In addition to the materials purchased by the Garden Ranger, EnrichLA supplies materials to be utilized by all schools/ Garden Rangers. This includes any supplies to grow from seeds (seeds, trays, seedlings, starter soil) any tools (shovels, trowels, hand forks, clippers, gloves, etc.), any general soil amendments (compost, fertilizer, mulch, organic bug sprays), any garden structures (trellises, etc.) and any outreach/ printing materials used at or by the school throughout the year. Some of these materials EnrichLA recycles, while others are bought in bulk to lower the cost, which is why we are able to keep the cost around \$500/school for the entire year.

Lastly, EnrichLA allocates a minimum of \$500 for each school to cover the cost of emergency repairs and any garden amendments. Gardens constantly need attention, whether they are affected by weather, need an irrigation adjustment, or demand a garden amendment to increase the function and success of each Garden Ranger Program (often includes building a compost bin, kitchen sink, picnic tables, signage, etc.). Typically repairs occur during the summer as all schools are being maintained while not session. The majority of schools demand volunteer work days to fix irrigation or add garden amendments, often totalling to more than \$500.

We recently had to replace pipes in the irrigation at ALC which totalled to \$250, which was paid by Enrich LA. This leaves us with only \$250 for the remaining full year. Below, you will find a breakdown of the total cost of the Garden Ranger Program, followed by the breakdown of materials budget for ALC Miguel Contreras.

Garden Ranger Program - Budget Breakdown



#### **Budget Items**

- Our Garden Rangers are paid, on average, \$90 per week for at least 4 hours of teaching/garden maintenance, per school. Total per school = \$4,140 (includes summer maintenance)
- Materials are \$40 per week per school throughout the school year\*. Includes repair materials for irrigation system and beds, amendments, etc. Total per school = \$1,520
- Operation Director, Program Director and Executive Director salary per school = \$600.00
- Administrative overhead and contingency funds per school, including insurance and workers compensation = \$640.00

\*38 average weeks in the LAUSD yearly calendar. This includes the cost of additional grocery items required for tastings, intermittent gardening supplies, and art supplies required for class activities.
