Dear Councilmembers,

On March 11, 2021 the ERA2 provided up to \$21.55 billion under the American Rescue Plan Act of 2021, which was enacted to help the people throughout the country. The funds were provided directly to states such as California to local governments to distribute to help the constituents in the rental crisis due to the emergency of the state.

On April 30, 2021 renters who applied for the COVID-19 Emergency Rental Assistance Subsidy Program through HICID have been put on hold to participate and receive funds for past due rent due to the COVID-19 Pandemic. The program has stalled in movement in going forward with applications from tenants and landlords. As of September 2021, millions of Californians and Angelenos have yet to pay rent and many face evictions as the rental moratorium approaches the end of its term.

Within the boundaries of the Westlake Neighbor Council Neighborhood and all surround areas resident have voiced concerns about evictions coming soon. Landlords have also expressed into coming close to foreclosures of their properties. Many renters many end up homeless very soon and Landlords, that are also small business owners could be forced to fall into foreclosure. Tenants and Landlords alike share the same

fate in loss if nothing is done by our leadership in the Los Angeles City Council member. The outside organization has had ample time to process applications. We urge you to demand HICID to speed up and process in reviewing applications.

The economic devastation of COVID-19 has been felt in our neighborhood and it is imperative we address the shortcomings of this well-intended rent subsidy program to ensure we are justly providing assistance to renters and landlords who are in need.

Therefore, Westlake North Neighborhood Council (WNNC) expresses its support for Council File:_____ and asks the city to report back to the Housing Committee transparency with a percentage of how many tenants and landlords have currently received ERA2 assistance and recommendations on how the City could require HICID to move faster in the reviewal and approval process.

In the citywide Emergency Rental Assistance Subsidy Program in order to address these unintended consequences of depriving tenants and landlords throughout the City from their right to receive aid. WNNC supports transparency and the movement of distribution of funds from HICID to the constitutes who are depending the assistance with the funding that that HICID has been entrusted with to distribute to renters and landlords.
