Due to financial impact brought on by COVID-19, to provide free produce bags, health and safety resources to the Westlake Neighborhood through a weekly Grab and Go event at 599 Columbia Avenue., Los Angeles, CA 90017 (corner of 6th street and Columbia Ave). The emergency Grab and Go has grown to now provide 350-400 families with fresh and healthy

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

Since March 2020, CultivaLA has supplied fresh herbs and vegetables to seniors, individuals and families within the Westlake Neighborhood through our weekly Emergency Grab and Go food bags. Every Thursday, 30 volunteers donate their time to set up tables, canopies and assembly stations at the Westlake Community Garden to safely distribute food bags to the community.

Adhering to social distancing and other safety recommendations provided by the Los Angeles Department of Public Health, CultivaLA volunteers carefully pack food bags with swiss chard, celery, parsley and cilantro, grown locally by our community gardens. Grab and Go bags are also supplied with a healthy variety of fruits and vegetables from a local food distributor.
