#### RE: Marijuana (Cannabis) Regulatory Framework - Council File No. 14-0366-S5

Dear City Residents:

The City Council is in the beginning stages of an open and public conversation about how best to regulate all aspects of the marijuana, or cannabis, industry within the City of Los Angeles. It also marks another important opportunity for the Neighborhood Councils to be fully engaged in the City's legislative process and truly have a seat at the table. As Chair of the REIRN Committee that will oversee this process and also oversees Neighborhood Councils, once again this is your time to shine and show the City and its residents the importance and value you bring to City government. These are your communities ... your neighborhoods, and together we will have a robust conversation about the regulatory issues concerning the cannabis industry and a healthy debate prior to recommending anything to the full City Council.

As part of our conversation over the next few months, we are requesting that each Neighborhood Council, Alliance, and citywide committee agendize this item for discussion and action at your October or November meetings. We want you to take advantage of this opportunity to provide the City Council's REIRN Committee with Community Impact Statements, white papers, suggestions and recommendations. We will consider all the information provided to us prior to the City Council making any major decisions.

Furthermore, we plan on holding at least three regional meetings throughout the City, partnering with the Neighborhood Council Alliances, the Neighborhood Councils in each region, and cannabis industry groups to host and participate as full partners in this conversation.

Lastly, we also want to ensure that other residents, including homeowner groups, civic organizations, business groups, and others participate in this process, and we look forward to discussing this further with many of you. As part of this process, my office will be setting up a working group of neighborhood council leaders and cannabis industry advocates to help develop and advise my office on a balanced approach that will respect our communities, and at the same time, finally provide the proper regulatory, enforcement, and taxation framework for cannabis in the City of Los Angeles.

My staff will be reaching out to you shortly to participate in these meetings in October and November of this year, and we look forward to your partnership and engagement.

#### MOTION

The City of Los Angeles has diligently worked to regulate and collect tax revenue from Medical Marijuana Dispensaries (MMDs) over the last three years. Prior to 2013, however, the previous seven years was marked with several lawsuits and an explosion in MMDs, particularly with regard to retail establishments. In response and with little direction from the State of California, the voters of the City of Los Angeles enacted Proposition D in May of 2013, which passed with almost 63 percent voting in favor of the measure. With the enactment of Proposition D came welcomed change, but new challenges.

Proposition D has been the primary tool utilized by the City of Los Angeles, particularly the City Attorney's office, to provide the necessary enforcement and regulatory framework for medical marijuana in the absence of state regulation. While Proposition D has been effective in providing enforcement and shuttering hundreds of illegal dispensaries, according to some statistics there are still dozens of illegal MMDs operating and further enforcement is needed. Furthermore, with the newly enacted state law in 2015, the Medical Marijuana Regulation and Safety Act (MMRSA), it is time for the City of Los Angeles to make adjustments to Proposition D allowing the City's medical marijuana regulatory framework to better conform with state law prior to January 1, 2018.

Lastly, the City of Los Angeles should explore financial opportunities associated with the recreational use, cultivation, distribution, manufacturing, processing, and testing of marijuana. The City should be prepared for potential passage of the Adult Use of Marijuana Act (AUMA) in November of 2016 which would allow for the recreational use of marijuana, as well as a licensing system for cultivation, manufacturing, processing, distribution, and testing of marijuana as required under MMRSA and AUMA. A new revenue stream generated by such activities would provide City residents with enhanced constituent services and a better quality of life.

WE THEREFORE MOVE that the City Council INSTRUCT the Chief Legislative Analyst (CLA) and the City Administrative Office (CAO), with the assistance of the City Attorney's office, the Department of City Planning, the Department of Building and Safety, the Office of Finance, and the Police Department, to report back in 60 days with options for a March 2017 ballot measure that will allow Proposition D compliant dispensaries to conform to the newly created medical marijuana state licensing system, increase penalties and enforcement to close down all illegal marijuana-related businesses, create a regulatory framework for the City to implement the Adult Use of Marijuana Act (AUMA) if approved in November, and extend Proposition D's gross receipts tax to all marijuana-related businesses.

  - c. Senior Lead Officer, Rampart Station, LAPD: From notes of Ashley and Ive:

- Officer Frank Garcia noted that crime is down 18%; theft up 1%. Rampart is the third best in the City for lowering crime.

- As to increasing theft at the Food 4 Less at 1700 West Sixth Street, watch your property while shopping. They have placed large cardboard "mock officers" signs/posters with the message "Crime will get you time, it's not worth the risk" at local grocery, retail, and liquor stores. Continue to see GTAs, with cars and trucks getting stolen.

- As to homeless encampments on Beverly Blvd., he noted that the homeless users may be offered to meet with a manager of methadone clinic which would help them to leave the area; only two people wanted help.

- He reminded us to use 311 for bulky item pickup.

- He related crime incidents including a shooting two to three weeks ago. Asked if we should we call if we hear gunshots, Deputy Garcia replied yes; though calls are prioritized, it can help.

- Asked about legal street vendor selling, he noted that regulations & rules are being enforced at red box areas, MTA entrance/exits, in front of a fire hydrants; there should be no nude pictures/porn, no conflict of goods with local stores, no live animals; however, he noted that this problem is too large to be enforced at this time. The vendors have to take classes the last Wednesday of the month, to be able to sell their products.

- Asked about security at Rite Aid, a friend harmed in theft, Officer Garcia informed us all there is no mandate for security at these stores, recommended putting up <u>no</u> fight and filing a report. He reminded us of Christmas coming up.

- He reminded us that they are having Christmas for the children again this year and need volunteers.

d. Mark Gonzales, District Director, from State Assemblyman's Miguel Santiago, Office from District 53, spoke on State ballot initiatives including raise of the minimum wage; on homelessness. They have asked the Governor to declare a State of Emergency, and though no act was approved, there has been movement as a result. He noted that they are now seeing young families and single mothers.
- He discussed the proposed plan for 3.6 billion of Federal and State repurposed dollars to address the issue of homelessness; approximately 2 billion with first disbursement in January. This is the "Housing first model" bill with vouchers for 30 days to help allow time for homeless families to get back in housing.

- Other initiatives are for all gun purchases and loans to now require background checks, another to clean up battery lead recycling plant pollution, for 176 million dollars; AB118 was passed to help

clean up, create local jobs, accountability of legislature, engage public. Schools were also cleaned up in the area, after 33 years of pollution, with further cleanup over the next year.

- Ashley asked how his office can help us with low-income housing, to which Mr. Gonzales replied that this is a city issue, and he is with the state.

- As to a tax credit for affordable housing, he noted that the Governor approved \$400 million, with plans for renegotiation next year to allow use of funds; however, noted that at the end of the day local municipality must decide.
